The main objective of this Ride is to raise funds for The Rainbow Society of Alberta while enjoying the great outdoors and having fun. The safety and well-being of all riders and horses is of paramount importance. Please allow us to bring the following to your attention:

1. NO LIQUOR, DRUGS, OR FIREARMS WILL BE PERMITTED.
2. CHILDREN UNDER 18 YEARS OF AGE ARE TO BE ACCOMPANIED BY AN ADULT.
3. THE MINIMUM AGE OF ANY HORSE ENTERING THE RIDE IS THREE (3) YEARS.
4. ALL HORSES MUST BE SOUND AND IN GOOD CONDITION.
5. ALL KICKERS MUST BE IDENTIFIED BY PLACING A RED RIBBON ON ITS TAIL.
6. ALL STALLIONS MUST BE IDENTIFIED WITH A DOUBLE RED RIBBON AND DOUBLE TIED.
7. NO DOGS ALLOWED ON TRAIL.
8. HORSES, WATER, FEED, AND TRANSPORTATION ARE THE RESPONSIBILITY OF THE RIDER. HORSE SHOES ARE NOT REQUIRED FOR THIS RIDE
